- 2. Managers category holding GDRFA-approved designations with basic salary from AED 30,000* (*subject to change as per Immigration rules)

Navigation:


- 1. Login to **Dubai Trade**
- 2. Go to **Employee Services** from the menu on the left
- 3. Then go to NOC for Golden Visa

The below screen will be displayed where you can **Create**, **View** or **Search for SR**.




Procedure:

1. To begin, click Create New Request




2. Choose the "Required Visa Type" and select Yes or No if the existing visa is under the same company.




3. For CEC holders, choose "Yes" to "Employee is in UAE" and if the applicant is continuing employment with the same company or not.

NOTE:

- a. Golden Visa NOC cannot be requested for Outside UAE Applicant
- b. Shareholders can choose not to continue with the company.
- c. Managers category should choose to continue employment with the same company, a new employment contract must be signed via DocuSign. In this case, a new CEC will also be issued.




For Shareholders, please search for the information and enter the necessary information:




4. Upload the documents to support your application.

Click "Continue and Review" to proceed.




5. Review the data entered. You can edit, view uploaded documents or proceed to the final step.



6. Confirm the charges and click "Submit to Freezone" for processing.

A confirmation message will be displayed and once verified and processed, the Golden Visa NOC will be issued as an EDV document.
