




From Company Profile, navigate to the VAT Profile on the left side of the page.




Use this page to create a new VAT profile and view and amend existing active or rejected profiles.



Initiate the creation of a new VAT profile by clicking "Create New".




All the agent codes associated with this user will be displayed for selection.




Automatic Selection of Agent Codes with Shared License Information

If a company has multiple company codes registered under the same license, the system will automatically detect this relationship. When a user attempts to update only one of these company codes, the system will automatically select all other agent codes that share the same license information. However, if you manually select multiple agent codes that are not associated with the same license, the system will prevent the update. This ensures that


updates are applied consistently across all related codes, maintaining data integrity and reducing the risk of mismatched information.



If Dubai Customs agent types are selected, a notification will show that you need to contact FTA if you wish to update your TRN or V.A.T. information with Dubai Customs.






The trade license information will be auto fetched, if available in the system. Kindly ensure that the **license number**, issuing authority and **license validity** information are correct.




If your request is **approved**, you can either view or amend your profile from this option. If your request is rejected, please resubmit your request by choosing the action "Amend Profile".
